**PUBLIC SYNOPSIS OF MAJOR DISCIPLINARY ACTION**

**2015**

**Two (2) Officers terminated for Inability to Perform Duties. Officers could not complete the necessary Training Academy required for employment.**

**Officer was suspended without pay for Inability to Perform Duties. Officer was dismissed from the Training Academy. The Officer appealed the dismissal and is awaiting final disposition.**

**Officer was suspended without pay for seven (7) days for Conduct Subversive to the good order and discipline of the department. Officer had a negative interaction with a member of the public.**

**Officer was suspended without pay for twelve (12) days for Conduct Unbecoming a Public employee. Officer used excessive force during an incident.**
